TELMA BRINGS THE UPMOST INTERNET CONNECTIVITY TO MADAGASCAR THROUGH 2AFRICA NEW SUBSEA CABLE

2Africa, the largest subsea cable system in the world, has landed at Mahajanga. Telma has partnered with Vodafone to link Madagascar to this first cable system designed to serve the whole of Africa and bring a seamless international connectivity up to three billion people. This new infrastructure will significantly reinforce Telma's capability to meet the fast-growing demand for online services in Madagascar. The 2Africa East cable system, of which the Mahajanga branch is part of, will be ready for service by the fourth quarter of 2023. Businesses and consumers will benefit from improved quality, reliability and lower latency for internet services, including telecommuting, high-definition video streaming, and advanced multimedia applications.

The largest subsea cable system in the world

Alcatel Submarine Networks (ASN) is responsible for deploying this 45 000-kilometre cable system, designed with a capacity of 180 Tbits per second, it will interconnect 33 countries in Africa, Europe, and the Middle East. Delivering more than the total combined capacity of all subsea cables serving Africa today, 2Africa will provide much-needed internet capacity and reliability across Africa supporting the growth of 4G, 5G, and fixed broadband access for hundreds of millions of people. According to a study by RTI International, 2Africa is expected to have an economic impact of USD 26.2-36.9 billion, or the equivalent of 0.42-0.58% of Africa's GDP, within two to three years after its commissioning.

EASSy, LION, METISS, and 2Africa connect the Island to the world through Telma's national backbone, which is the only optic fiber infrastructure serving the country's major cities. With the deployment of the 2Africa cable, Telma will significantly increase its capacities in internet connectivity.
